POLL RESULTS OF ANNUAL GENERAL MEETING
HELD ON FRIDAY, 25 FEBRUARY 2022

Reference is made to the notice (the “**Notice**”) of the annual general meeting (the “**AGM**”) of China New Higher Education Group Limited (the “**Company**”) and the circular (the “**Circular**”) of the Company, both dated 30 December 2021; and the notice of special arrangements for the AGM dated 21 February 2022. Unless otherwise indicated, capitalised terms used herein have the same meanings as those defined in the Notice and the Circular.

POLL RESULTS OF AGM

At the AGM held on 25 February 2022, pursuant to the Listing Rules requirements and the provisions of the Articles, the chairman of the AGM has required voting by poll on all the proposed resolutions (the “**Proposed Resolutions**”) as set out in the Notice. All the Proposed Resolutions were duly passed by Shareholders by way of poll at the AGM.

As at the date of the AGM, the total number of issued Shares of the Company was 1,567,447,630 Shares, which was the total number of Shares entitling the holders to attend and vote for or against the Proposed Resolutions. There was no restriction on any Shareholders to vote only against the Proposed Resolutions at the AGM. There were no Shares entitling the Shareholders to attend and abstain from voting in favour of any of the Proposed Resolutions as set out in Rule 13.40 of the Listing Rules. No Shareholder was required under the Listing Rules to abstain from voting on any Proposed Resolutions. None of the Shareholders has stated his/her intention in the Circular to vote against the Proposed Resolutions or to abstain from voting on any Proposed Resolutions at the AGM. All the Directors had attended the AGM.

The Company's branch share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited, was appointed as the scrutineer for the purpose of vote-taking at the AGM.
